Foreign principal: European Travel Commission.

Organized a Travel Fair which was held at the Americana Hotel, New York City, on September 9, 1971. Booths were occupied by representatives of the ETC member tourist offices, trans-Atlantic carriers and tour operators who distributed literature to travel agents promoting travel to Europe during the off-season.

Compiled and distributed to travel agents a sales manual listing tours which operate to the European member countries. (See copy attached.)

Produced and scheduled one-minute spot radio commercials in which representatives of the ETC member national tourist offices described the advantages of off-season travel to their respective countries. The commercials ran, non-consecutively, from the end of August for nine weeks in the New York market (Stations WCBS, WNBC, WINS, WQXR); eight weeks in the Chicago market (WIND, WCLR-FM, WJJD, WNUS); and seven weeks in each of the following markets: Los Angeles (KFWB, KFAC, KABC, KPOL), San Francisco (KABL, KKHI, KNBR), and Boston (WBZ, WCRB, WCOP, WEET).

Organized a luncheon for the travel press attending the American Society of Travel Agents Convention in Sydney, Australia, on November 1.
