Dear Dr. Uribe:

As promised, here is my letter confirming our arrangements.

Subject to final confirmation from Bogota, we have been retained as public relations counsel to the Colombia Information Service of the Republic of Colombia effective December 1, 1966. Our agreement will cover a period of one year and may be renewed or cancelled at the end of the year by either party.

Our fee initially will be at the rate of \$36,000 per year. In accordance with our standard procedures, we will bill you on the first of each month starting December 1st at the rate of \$3,000 per month. This basic fee covers all management and operational time involved in planning, writing, and development and execution of programs.

In view of your request that our fee be limited to \$36,000 per year as opposed to the \$48,000 originally outlined in our proposal of October 17th, it must be borne in mind that we are going to have to work together to temper the program as outlined in the proposal to fit within the limitations of the smaller budget and be more selective in our programming than we would otherwise like. However, in view of the magnitude of the job to be done, we propose to review the question of over-all budget with you by the end of the first three months of operation.

Within 30 to 45 days following the period of orientation and indoctrination in which our staff will participate both here and in Colombia, we will prepare a detailed expense budget covering anticipated costs together with a detailed program of activities which we plan to carry out. Arrangements for meetings and travel in connection with this orientation period will be started immediately, as well as the other immediate assignments covered in our discussions.

I would appreciate your initialing this letter in the appropriate place and returning a copy to me as confirmation of our arrangements and also to permit us to complete the necessary forms that must be filed with the Department of Justice in Washington, D. C.

In conclusion, I would simply like to say again how delighted and proud we are to be working for the Republic of Colombia. We will do everything in our power to justify your confidence in us.

PRE-HISPANIC "TREASURES OF EL DORADO" GOLD ART
EXHIBITION AT COLOMBIAN CENTER

New York, N.Y. -- A unique collection of pre-Hispanic gold art and artifacts from Colombia is currently on exhibit at the Colombian Center of the Republic of Colombia, 140 East 57th Street, New York City.

The "Treasures of El Dorado" includes 208 rare gold objects selected from the world-famous collection of Banco de la Republica of Bogota and from private collectors. The objects, which are highly sophisticated in process and form, exemplify the magnificent craftsmanship of Colombia's ancient artisans.

The "Treasures of El Dorado" exhibit is divided into categories representing the eight distinct regions of ancient Colombia: Calima, Quimbaya, Darien, Sinu, Tairona, Muisca, Tolima, and Chibcha.

The Colombia Information Service is registered under the Foreign Agents Act as agent of the Colombian Center of the Republic of Colombia, 140 E. 57th St., New York City. Copies of registration statement and this material are filed with the Justice Department. Registration does not indicate approval of this material by the U.S. Government.

The collection covers a variety of body and face ornaments, anthropomorphic and zoomorphic figures, face masks, and vessels. The objects are worked in thin gold sheet, thin gold wire, decorative gold thread filigree, and gold leaf.

The "Treasures of El Dorado" exhibit will run through January 31, 1967, at the Colombian Center, 140 East 57th Street, New York City. The exhibit is free of charge and is open Monday through Saturday, 10 a.m. to 6 p.m.

The Colombian Center has been established by the Republic of Colombia as a unique show-window into Colombia. The Center, which was officially opened on September 27, will present a series of exhibits highlighting the economic and cultural life of Colombia. The "Treasures of El Dorado" is the first in the series.
