On August 22, 2025, the Foreign Principal engaged the Registrant via a signed agreement letter to represent it in proceedings related to administrative sanctions and similar measures applied by the government of the United States, including litigation matters. Subsequent to the August agreement letter, the Registrant and Foreign Principal verbally agreed on September 10, 2025 to expand the scope of the arrangement to include potentially registrable activity. The agreement is to last for 48 months and the estimated total value of the contract is capped at \$3,542,000 for all services rendered, including non-registrable litigation and administrative matters and potentially registrable activity.
