Privacy Act Statement. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, DC. Bolivarian Republic of Venezuela under President Juan Guaidó

Bolivarian Republic of Venezuela under President Juan Guaidó

In support of the primary registrant, the short-form registrant may engage in political activities on behalf of the foreign principal, including making contact with U.S. government officials concerning the preservation of Venezuela's assets in the United States, the establishment of a diplomatic presence, and economic and humanitarian assistance.

Republic of Honduras

In support of the primary registrant, the short-form registrant may engage in political activities on behalf of the foreign principal, including making contact with U.S. officials in connection with due diligence for financing in the international market, including with respect to U.S. economic and technical assistance to Honduras, and matters affecting U.S.-Honduran relations.
