The Industrial Development Authority serviced inquiries about Ireland and supplied 530 companies and individuals with brochures (which have been labeled and filed as required) outlining the incentives offered by the Government of Ireland to manufacturers who locate manufacturing plants in Ireland. The inquiries were generated by an advertising campaign in the Wall St. Journal: Fortune: and the following trade magazines:- "Food Processing": "Plastics World": "Production": "Appliance Manufacturer". We also issued our autumn "Newsletter" to some 5,000 industrialists, Press and individuals: we held eight press interviews and one radio interview on the Barry Gray Show (WMCA)

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).
