Under a signed agreement dated 7/20/80 (filed with the Justice Department 10/19/80) World Magazine Communications, Inc. has contracted with the registrant for distribution in the United States of film packages acquired. The Republic of Cameroon program is the first acquisition and registrant has arranged for transmission via Modern Satellite Network, RCA SATCOM 3R, to a network of approximately 540 affiliates serving more than 10 million subscribers. The program runs 28" in length and aired October 11 and November 8, 1984. Our rate is \$1,990/showing.


Synopsis of program: The Republic of Cameroon's development in agriculture, farming and industry.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Registrant will provide distribution of this foreign principal's program titled "CAMEROON PANORAMA" on 3/4 NTSC tape, to cable systems affiliated with Modern Satellite Network throughout the U.S. Each program will be listed in a monthly program guide and periodic reports of usage by these cable systems will be provided. Distribution to community audiences and television stations may be included at a future date.

This very fine documentary would do well in U.S. distribution and I know that your plans are to release this shortly both for television and communitiy group audiences (business-oriented audiences). With this in mind I recommend that you cut the film from its current running time of slightly more than 32 minutes to 28 minutes, 30 seconds. This will be the best accepted time for both television, cable television, Modern Satellite Network and business groups.

If not, we'll maintain the two dates reserved in the Business View Program and perhaps consider doing an additional transmission at the beginning of 1985 in your Modern Special Program.
