The agreement provides for the Republic of Indonesia to make quarterly payments in U.S. dollars based on its volume of tea sold to the U.S. tea trade in support of a generic campaign for the promotion of tea consumption without regard to brand or country of origin.

The Republic of Indonesia will have two Directors on a twelve member Board which reviews and passes judgement on publicity and promotion programs designed to increase public awareness and consumption of hot and iced tea...without regard to what brand or type of tea or what country the tea comes from. The Tea Council's sole function is the promotion of tea as a generic product.
