The understanding between the registrant and the foreign principal, reached in a conversation on December 31, 1970, was as follows:

(a) that the registrant would provide advice and counsel, on request, in connection with the planning of press releases and public statements or speeches by Embassy officials during the period January 1 - March 31, 1971; (b) that registrant would receive fees totaling no more than \$3,000 for these services during this period; and (c) that the registrant would be reimbursed at cost for travel, telephone, postage, secretarial and other out-of-pocket expenses incurred in providing these services.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.
