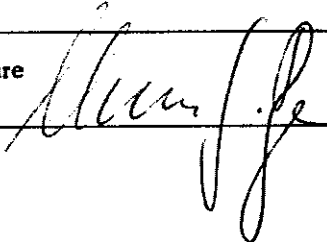

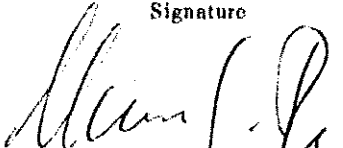

As result of various meetings and discussion it was agreed that the official representatives of the member countries in the USA will represent the Alpine Tourist Commission in this country. The sole purpose of the organization is the promotion of tourist traffic to the Alpine regions of Europe. Duration of this agreement depends on decision of the European principals (Official tourist organizations of Austria, France, Germany, Italy, Monaco, Switzerland, Yugoslavia). Expenses of activities are paid by the European principals (see 14(a) and 15(a) under IV -FINANCIAL INFORMATION of Supplemental Statement.
- Describe fully the nature and method of performance of the above indicated agreement or understanding.
There are several meetins held annually to discuss promotion campaigns, distribution of literature, advertising. A Public Relations firm is engaged on a very limited scale for contacts with the travel industry, - a mailing house for the distribution of literature.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Contact with different branches of the travel industry such as carriers, travel bureaus, travel editors of papers, magazines, and supplying them with information on the Alps, pictures, news items; information on the Alpine Motoring Contest (a promotion campaign to enhance visits to the Alps) offering various prizes as per attached control book. A limited advertising campaign is conducted. A travel film featuring the Alpine regions is loaned out free of charge.

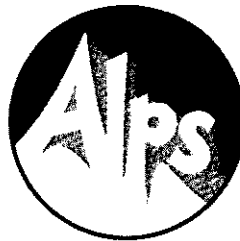

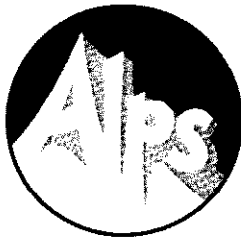
More and more Americans are discovering the thrill of a vacation driving their own or rented car over the network of excellent roads which crisscross the Alps.

2. Only one entry consisting of one photograph may be submitted by each person entering the competition.
3. Entry consists of a transparency, a slide or a black and white print no larger than 4 x 6 inches. The following information must be attached to the back of your photograph or printed on a slide mount: Your name and address; where was the photograph taken; date, and identification of subject.
4. Entry should be mailed to: Alpine Tourist Commission, P.O. Box 227, Lindenhurst, N.Y. 11757 and postmarked no later than October 30, 1973.
5. The Grand Prize will be awarded to the photograph that best captures and portrays the Alpine atmosphere. Runner-Up Prizes will be awarded to the next 7 best photographs entered.
6. Decision of the judges will be final, and winners will be notified by mail by December 31, 1973. On request, a list of the eight winners can be obtained by writing the Alpine Tourist Commission, P.O. Box 227, Lindenhurst, New York 11757.
7. All entries become the property of the Alpine Tourist Commission and may be used for advertising, publicity or any other purpose. No photographs, negatives, slides or prints will be returned to entrants.
