**Re: *First Amendment to the Engagement of Squire Patton Boggs (US) LLP***

Your Excellency:

Squire Patton Boggs (US) LLP ("SPB") remains deeply honored to advise the Office of the Presidency of the Government of Angola (the "Government"). The Government has requested that SPB expand its scope of work described in the enclosed Engagement Agreement between SPB and the Government dated June 18, 2021 (the "Engagement Agreement").

In this agreement (the "First Amendment"), the Government and SPB agree, as follows:

1. The scope and amount of work SPB is performing to support the Government during the ongoing Financial Action Task Force / Eastern and Southern Africa Anti-Money Laundering Group Mutual Evaluation, is beyond the scope of work and budget set forth in the Engagement Agreement; and
2. Upon signature of this First Amendment, the Government will make a supplemental payment of US\$900,000, covering the expanded scope of work for the period January 1, 2022 through June 17, 2022 (the "Supplemental Payment").

Except as expressly stated herein, all other terms of the Engagement Agreement shall continue in full force and effect.

Please confirm your acceptance of this First Amendment by countersigning the enclosed copy of this letter and returning it to me. If you do not agree with one or more of the provisions of this First Amendment, please contact me so that we can try to address your concerns. You should also feel free to consult with independent counsel before signing. Throughout our relationship, we want you to be satisfied with the professional services that we perform on your behalf. Accordingly, we encourage you to contact us just as soon as you have any questions or concerns regarding our services or our fees.



Your Excellency, thank you again for your confidence in our work. It remains our great honor to represent the Presidency and, through it, the people of Angola.


