Dear Dr. Fauci, by way of background and introduction, I am the former Inspector General of both the U.S. Departments of State and Homeland Security, and I am now a partner in the Washington office of the global law firm, Squire Patton Boggs. I am writing to you on behalf of our client, the Embassy of the Republic of Korea, with an urgent request that you meet with the Deputy National Security Advisor to the President, Hyun-chong Kim, next week concerning the coronavirus.

The purpose of the meeting would be to explain to the U.S. government Korea's current and expected efforts to combat and contain the virus, and Mr. Kim would provide an in-depth briefing concerning these topics. He is preparing to leave Seoul tomorrow and would be available to meet with you here in Washington anytime on Wednesday, March 4, or if more convenient for you, anytime the preceding afternoon, March 3.

During his visit to Washington, fyi, Mr. Kim seeks to meet with both you and the CDC's Principal Deputy Director, Anne Schuchat. We are mindful of how incredibly busy you are at this time and so either meeting with you two at the same time or separately would be perfectly fine for him. If your schedule does not permit a meeting on this admittedly rather short notice, we would be grateful if you would designate a high-level alternative in your stead.

Thank you very much for considering this request, and we hope for a quick and favorable reply from your office.
