This report is available to the public.



This material was transmitted in the course of meetings on December 15, 1994, between Hogan & Hartson L.L.P. attorneys and staff members of the Aviation Subcommittee of the Senate Commerce, Science, and Transportation Committee and the Aviation Subcommittee of the House Public Works and Transportation Committee. While this material has been labeled as required by the Act, a ministerial error was made in connection with the December 14, 1994 meetings. The materials at that time were labeled with the foreign agent disclosure of another firm that is also a registered foreign agent of the foreign principal, Avions de Transport Regional Groupement d'Interet Economique ("ATR").
