In support of this activity, CETRA sponsors numerous activities, including trade fairs and the management of an exhibition complex in Taipei.

CETRA is financed by revenues paid by Taiwanese importers and exporters; the government is involved in the management of these funds.

The registrant will provide the foreign principal with ongoing monitoring, advising and lobbying services relating to trade and other economic developments involving the U.S. Government which are of concern to the foreign principal. The registrant will prepare a regular report for the foreign principal addressing trade and economic developments affecting the U.S.-Republic of China relationship. The registrant will also be available to advise and assist the foreign principal with environmental or other regulatory matters, treaty negotiation and interpretation matters, and to represent the foreign principal in judicial or administrative proceedings.
