Foreign principal has indicated it will compensate this firm at the rate of \$55,000 per month, inclusive of legal services and expenses. This arrangement may be discontinued at any time at discretion of Foreign Principal, with no advance notice, except that Registrant will receive payment on a pro rata basis for any days of any month during which work was performed at the time of termination of the arrangement.

The firm will provide legal counsel regarding the restoration of the democratically elected Government of Haiti.
