
Dear Mr. Ambassador:

Pursuant to our mutual understanding, this letter serves as confirmation by the Royal Embassy of Saudi Arabia of the extension of the Agreement between Hogan & Hartson and the Royal Embassy of Saudi Arabia. The terms of the engagement set forth in the Letter Agreement of July 20, 2007, between Hogan & Hartson and the Royal Embassy of Saudi Arabia will be extended from January 1, 2009 and continue through December 31, 2009. The revised monthly retainer amount for the period January 1 – December 31, 2009 will be US\$50,000.00, plus reasonable out-of-pocket expenses to be billed in addition. The revised 2009 annual retainer will be paid in quarterly installments: \$150,000.00 by January 1; \$150,000.00 by April 1; \$150,000.00 by July 1; and \$150,000.00 by October 1. All other terms and conditions of the above-referenced Agreement shall remain in full force and effect. To the extent we are engaged in work on specific projects that may require unanticipated and significant commitments of time, the parties will agree to additional compensation as warranted and appropriate.
