Your Excellency:

Pursuant to our mutual understanding, this letter serves as a confirmation by the Ministry of Foreign Affairs of Saudi Arabia of the extension of the Agreement between Hogan Lovells US LLP (formerly Hogan & Hartson LLP) and the Royal Embassy of Saudi Arabia. The terms of the engagement set forth in the Letter Agreement of July 20, 2007, as amended, between Hogan Lovells US LLP and the Royal Embassy of Saudi Arabia will be extended as of January 1, 2017, and continue through December 31, 2017. The monthly retainer amount for the period January 1- December 31, 2017, will be US \$125,000.00, plus reasonable out-of-pocket expenses to be billed in addition. The 2017 retainer will be paid in installments; \$375,000.00 is due now for the period January 1 - March 31, 2017; \$375,000.00 is due by March 31 for the period of April 1 - June 30, 2017; \$375,000.00 is due by June 30 for the period of July 1 - September 30, 2017; and \$375,000.00 is due by September 30 for the period October 1 - December 31, 2017. This Agreement shall terminate on December 31, 2017, unless extended upon written agreement by both parties. All other terms and conditions of the above-referenced Agreement shall remain in full force and effect. To the extent we are engaged in work on specific projects that may require unanticipated and significant commitments of time, the parties will agree to additional compensation as warranted and appropriate.
