



The foreign principal on whose behalf the Registrant functions in the United States is World Zionist Organization (W.Z.O.) whose main office is located in Jerusalem.

The general objectives of W.Z.O. are:

To foster the ideals of Zionism and Judaism, and the unity of the Jewish people, to encourage the immigration of Jews to Israel and their resettlement and rehabilitation therein in industry, agriculture, commerce and the trades; and to assist and further their cultural, educational, religious, social, artistic and scientific endeavors.

To encourage, foster and promote the knowledge and study of Hebrew language and literature, Jewish culture, history, philosophy and traditions, and the achievement of the Zionist ideal; and in connection therewith, to disseminate, publish and otherwise make available cultural, literary, religious, social, artistic, scientific and other publications and works relating to Judaism, Zionism, Israel and kindred subjects.

Generally, the purpose of the Registrant's activities is to gain the increasing and continuing support of the American Jewish community for the above-mentioned objectives. However, the specific activities of the Registrant are primarily educational, cultural and religious and are carried out by its various departments, as more fully set forth in schedule "B" attached hereto.

MAKOM

- Makom and its partner communities continue to develop Israel education initiatives in local institutions.
- Examining the ways Makom can continue to work with its communities in light of the financial difficulties they are facing.
- Working on the development of the Makom institute that will train and provide educational resources to different organizations in North America.
- Makom created partnerships with national Jewish organizations and began to develop joint initiatives with them too.
- Makom continues the process of mapping in different communities.
- The Center for Involvement and Collaboration of the BJE in NY has a new youth initiative centered on Israel and social justice. Makom is a partner in the planning process of this initiative.
- Working on "Netivel MASA" the professional development for Jewish educators from a variety of settings, such as day schools and synagogues.

MASA

- Continue to develop and foster Study Abroad partnerships between Israeli and American universities
- Developed an IPR (Israel program Request) system to track and follow up with applicants.
- Planning events and missions, working on recruitment campaigns, and continuing the recruitment for this year.
- Regional representatives were placed in two federations. L.A. and Chicago. MASA is looking to hire more representatives in other cities across the U.S. to help with recruitment and work with alumni.
- Expanded the university Campus Representative program for marketing and recruiting in collaboration with Hillel- 50 campus interns represent MASA in universities across the U.S. Their training was held in January.
- Continue to develop strategic partnerships with national Jewish and study-abroad related organizations as platforms for greater recruitment.
- Launched new marketing initiatives for gap year programs, study abroad, volunteer and internship programs.

- A mission of high school advisors was held in January. A second mission of career services professionals from major universities across the U.S. was held in May.

Israel Educators – Summer and Volunteer

Summer Camps

- Working closely with camps and Emissaries (by phone, e-mail and newsletters) to provide them with ideas on strengthening their connection to Israel.
- Working to finalize the contracts with the summer camps. Registration and assignment of shlichim for the summer camps has been completed.
- The summer camp team has been working with the Henry Kaufman Camp Grounds on creating a new model of day camp for young children ages 3-14 in Long Island.

Young Emissaries

- Provided continuing support, training materials and guidance to Emissaries year round
- Worked with federations and communities to provide them with the guidance and support needed to work with their Emissaries
- Working with new communities to strengthen their young shlichut (the term during which they act as emissaries to the communities).
- Beginning of discussions with new communities about receiving young emissaries

Community and Youth Organization Emissaries

- Provided continuing support, training materials and guidance to Emissaries year round
- In-service training of Emissaries through community visits, conference calls and individual monitoring
- Working with the communities that are facing financial difficulties on alternate models for their shlichut.
- Emissaries to youth organizations and movements work on an ongoing basis to strengthen Jewish and Israel education
- Holding discussions with federation executives about the future of their emissaries.

Schools

- Continued the regional in-service trainings for school based shlichim.

- Working to develop a relationship and form cooperation with CAJE- the Coalition for the Advancement of Jewish Education.
- Working intensively on the Oded project (Outstanding Day-School Educators). The project brings 60 exemplary Israeli teachers to Jewish day schools in the Diaspora. The project requires extensive work with schools that will be able to receive the new shlichim.

College Outreach

- Expanded cooperation with Hillel on encouraging North American students to study and volunteer in Israel.
- New discussions are underway with MASA about expanding the MASA-Hillel partnership.
- The assignment process of the Hillel shlichim has been completed.
- Preparing the training program for the new shlichim.
- Working to strengthen the cooperation with MASA. MASA campus representatives will be better incorporated in the work of Hillel at the campus level.

FSU Émigrés (Former Soviet Union)

- Projects with partnering local student and communal organizations in the Russian Jewish field
- An Educational retreat for 100 young adults was held in N.Y. in May 2009.
- Working with the NY federation on several new programs.
- Missions of Russian speaking youth to Israel and Ukraine.
- Leadership development and training opportunities, working with teen leaders, students, camp counselors and young adults.
- New York area summer camps for teens from Russian speaking families.
- Working on the new national summer camp for FSU émigré teens with JAFI and Young Judaea.

General Education Activities

- The educational caravan project in New York was executed-groups of 3-4 shlichim held programs (peulot) in a few institutions such as the Prozdor School, Park Avenue Synagogue, and Midway Jewish Center.
- Israel Engagement Assembly- work continues on the project- 3 of the 5 assemblies were held in NY. A movie of the assemblies is being produced.
- Working to increase the involvement of the shlichim in MASA.
- Working to create educational materials by Makom.


