Have been retained to render legal services at \$200 per hour or maximum of \$1,000 per day. Activities of registrant have included drafting of agreements, straight legal research and giving advice directly to SABIC and Saudi officials on SABIC activities on non-registrable matters until Salimah, SABIC's chief operating officer decided in January 1985 to come to U.S. to meet with U.S. officials on pending legislation that would, if enacted, levy countervailing tariff on foreign-produced petrochemicals and other products imported into U.S.

Registrable activities undertaken in February 1985 included arranging for a single appointment for Salimah while he was on visit to U.S., with each of the following: Congressman Sam Gibbons, Secretary of Commerce Baldrige and U.S. Deputy Trade Representative Michael Smith, to discuss pending legislation described above with each of the three officials. Registrant has since continued to keep track of the status of the indicated legislation through published public sources but has not contacted or sought to influence U.S. sources, nor has SABIC, Saudi Embassy or other Saudi officials to best of Registrant's knowledge.
