

In addition to the material supplied, MR. NAIL ATALAY gave the following lectures:

April 19, 1977	Drew University, New Jersey
May 10, 1977	New York State University, Buffalo, N.Y.
May 20, 1977	Dartmouth College, New Hampshire
June 28, 1977	Garden Grove City Public Library, Los Angeles, Calif.
July 1, 1977	Stanford University, California

The lectures concerned the Turkish Cypriot viewpoint as it related to the question of a peaceful resolution of the Cyprus question. The balance of my activity during this period consisted of monitoring United Nations sessions and reporting my view of same to my principal.

The lectures indicated were all given by Nail Atalay, Director of the registrant herein. The subject matter consisted of the history of the Turkish-Greek habitation of Cyprus and the factors resulting in the present problem and the Turkish Cypriot viewpoint on a proposed solution. The lectures tended to contain the information indicated in disclosure statements dated 10-18-78.
