Item 5 (continued):

The second purpose of this amendment is to correct an ambiguity contained in the short-form registration statements filed by E. David Doane and Beverly A. Baughman on October 5, 1978. The information set forth in Item 10 of each statement should have included the fact that the described services relate only to one of the two foreign principals listed in Item 8. Therefore, Item 10 of each statement is revised to read as follows:

Short-Form Registration Statement for E. David Doane:

The services rendered to the Registrant (Item 7) consist of activities typically conducted by an attorney employed by a firm engaged in the general practice of law, including legal research and analysis, the preparation of legal documents, and communications with clients and regulatory agencies. I have rendered and will render services to only one of the two foreign principals listed in Item 8, namely, Neratoom, B.V. Those services consist of providing information and analyses concerning the civilian nuclear power policies of the U.S. Government. I will continue to provide those services, but only to Neratoom, B.V. New services to be rendered only to Neratoom, B.V. are described in Item 11.

Short-Form Registration Statement for Beverly A. Baughman:

I am employed as a paralegal by the Registrant. My services consist primarily of obtaining documents and information and conducting research and analyses pursuant to specific requests from attorneys. My activities requiring my registration consist of services to be performed for only one of the two foreign principals listed in Item 8, namely, Neratoom, B.V. I will attend one or more of the meetings described in Item 11.

The third purpose of this amendment is to withdraw the registration of Beverly A. Baughman, who filed a short-form registration statement on October 5, 1978. Although Ms. Baughman continues to be employed by the Registrant, she will not perform further services requiring her registration.
