LETTER OF APPOINTMENT

- Managing and overseeing staff, hiring and firing staff, overseeing budget, allocating funds, controlling costs and maintaining operations consistent with the headquarters' guidelines to ensure growth & exposure of TTCSF's service and achievement of organizational goals;
- Directing and supervising team to gather marketing data to develop marketing strategies and alternative measures; leading staff to establish and maintain business connections and networks, assess & improve the sourcing/marketing activities to ensure efficient sourcing process and management strategies are implemented; recommending to the headquarters new policy and procedures as well as alternative methods of providing services;
- Representing both TAITRA and TTCSF externally in all activities and events to promote its business goals and services;
- Establishing and maintaining close working relationships with other trade organizations, governmental agencies and cooperating agencies;
- Acting as an intermediary to assist U.S. enterprises who are interested in finding appropriate business partners and counterparts for doing business in Taiwan.

As Director of Taiwan Trade Center, San Francisco, Ms. Liu is to receive a monthly salary of USD\$5,200. We hereby declare that we shall answer for all of her expenses in U.S.A.

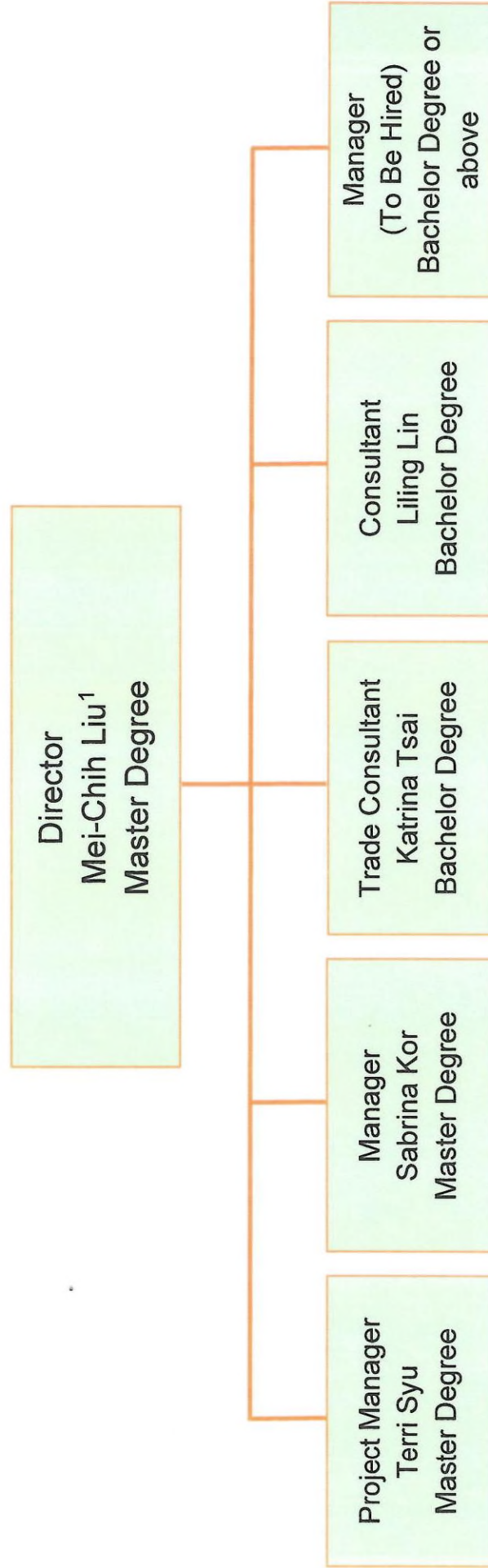
