This report is available to the public.



A G R E E M E N T

This Agreement is entered into by and between International Public Relations Co., Ltd. (hereinafter referred to as IPR) and Civic Service Incorporated (hereinafter referred to as CSI) with respect to activities in the United States relating to U.S. banking policy on behalf of the Mitsubishi Trust and Banking Corporation (MTBC).

ARTICLE 1. CSI will monitor and provide reports regarding the U.S. financial and monetary policies as well as developments on the structural reform in the financial industry.

ARTICLE 2. The period of this Agreement shall be for the six month period from October 1, 1992 through March 31, 1993.

ARTICLE 3. Fee for Activities shall be US\$21,000 excluding expenses, which are not to exceed US\$4,200 or 20% of the fee.


ARTICLE 4. IPR shall pay the amount of \$3,500 monthly and expenses at the end of each month as the monthly allotment for the preceding month. IPR shall remit by bank wire to the account of CSI at First National Bank of St. Louis Country St. Louis, Missouri 63105, Account No. 130977.


ARTICLE 5. CSI and IPR shall take measures necessary to safeguard any and all confidential information and/or materials of MTBC from third parties during the execution of Activities.

ARTICLE 6. In case decisions are required on matters not covered in this Agreement, such matters shall be handled and decisions made based on mutual agreement between CSI and IPR.
