

Thomson-CSF (France) is majority owned by Thomson S.A. (France). The balance of Thomson-CSF's shares are quoted on the Paris Stock Exchange. Financing of Thomson-CSF is through capital contributions from its majority shareholder, Thomson S.A. (France).

Thomson S.A. is a nationalized company, 100% owned by the Government of France. Financing of Thomson-CSF's parent company, Thomson S.A., is through capital increases from its shareholder, the Government of France. There is, therefore, indirect, remote financing of Thomson-CSF by a foreign government.
