China Daily Distribution Corp., in New York, is the newspapers' agent in North America and Europe. Services rendered to the foreign principal include: printing through contract with printer of China daily in Beijing, China, directly from photograph negatives; distribution of the newspaper; subscription and advertising in the United States.
