Addendum to Engagement Letter

This contract is between Akin Gump Strauss Hauer & Feld LLP ("the Firm") and the Republic of Korea Embassy ("the Embassy"). Pursuant to terms in prior agreements, the Firm will continue its representation of the Embassy in connection with strategic consulting and legislative outreach services with respect to promoting a professional visa initiative until terminated by either party.


The Embassy will pay the Firm a monthly retainer of \$30,000 for the contract period of June – December 2013, with the exception that the contract will revert to \$15,000 for the month of August 2013.

The Firm's representation will continue until notified, and the contract will be terminated immediately upon written notification.


