Re: Terms of Engagement

Dear Mr. Katumbi:

I am pleased to confirm our representation of you in connection with advice and representation in Washington, D.C. regarding greater U.S. support for democracy in Africa generally, and free and fair elections in the Democratic Republic of the Congo in particular.

The firm's policy is to describe the manner in which we will bill for legal services and disbursements. A clear understanding of those matters helps to maintain a harmonious professional relationship. I encourage you to consider the matters set forth in this letter carefully and to raise with us any questions that you may have now or later about its contents.

The fee for this representation shall be a fixed monthly fee of \$30,000 per month for services to be rendered for the period beginning on April 1, 2016 through November 30, 2016, inclusive. This fee includes a fee for services to be rendered by a public relations firm assisting us in this representation, DCI. In addition, the firm shall be reimbursed for all reasonable expenses that it incurs in connection with this representation.

As we have discussed, you have agreed to pay the entire fee for the six months of this representation of \$180,000 in one single payment in the form of a transfer of funds currently held in escrow by our firm on behalf of the company your formerly owned, MCK. Upon receipt of written confirmation from MCK, we will transfer the escrow account of MCK to an account in your personal name, Moise Katumbi, and bill our fees and disbursements against this escrow account for the balance of our engagement.


