Re: Re-engagement

Dear Mr. Katumbi:

I am pleased to confirm our re-engagement on your behalf in connection with advice and representation in Washington, D.C. regarding greater U.S. support for democracy in Africa generally, and free and fair elections in the Democratic Republic of Congo in particular. This letter supersedes all prior engagements and is effective as from May 15, 2019. Our firm's engagement will include coordination and management of two other firms, DCI Group LLC, and RMG Africa Advisors, LLC, and this engagement includes them as part of our team. It is agreed and understood that this representation will entail the team's registration under the Foreign Agents Registration Act.

The firm's policy is to describe the manner in which we will bill for legal service and disbursements. A clear understanding of these matters helps to maintain a harmonious professional relationship. I encourage you to consider the matters set forth in this letter carefully and to raise with us any question that you may have now or later about its contents.

Our fee for this representation, inclusive of all fees for our team members, shall be a fixed fee of \$45,000 per month, exclusive of incidental expenses incurred in connection with this representation. It is understood and agreed that travel expenses outside of the District of Columbia, authorized by you in advance, are not included as part of this monthly fee and shall be added to our monthly bill. This representation shall be effective as of May 15, 2019, and shall conclude December 31, 2019, unless renewed by mutual agreement.

As we have discussed, you have agreed to pay two and one half (2.5 months) of our monthly retainer, for a total of \$112,500, within thirty (30) days of the execution of this letter. We will invoice you every quarter thereafter for an amount equal to three months of our monthly retainer fees (\$135,000), plus reasonable disbursements incurred on your behalf.


