Re: First Amendment (the "Amendment") to that certain interim letter effective June 1, 2018 between White House Writer's Group, Inc. ("Client"), acting as agent of the Consulate General of Poland ("Consulate") and Daniel J. Edelman, Inc., doing business as Edelman ("Edelman").

Dear Clark:

Subject to the full execution of this Amendment, Client and Edelman hereby agree to amend the letter as follows:

• **TERM EXTENSION THROUGH JUNE 30, 2019**

Client and Edelman explicitly agree that notwithstanding the previous expiration of the letter, effective December 31, 2018, the term of the letter shall continue in full force and effect until June 30, 2019.

• **INCREASE TO MONTHLY RETAINER AS OF OCTOBER 2018**

The parties hereby agree to increase the Monthly Retainer amount from \$10,000 to \$20,000 commencing on November 1, 2018 through June 30, 2019. Therefore the Budget will be revised and replaced in its entirety with the following:

• **REVISED RETAINER BILLING SCHEDULE**

The parties hereby agree to update the Retainer Billing Schedule to cover the increased Monthly Retainer effective November 1, 2018 and term extension through June 30, 2019. Therefore the Retainer Billing Schedule will be revised and replaced in its entirety with the following:
