This report is available to the public.



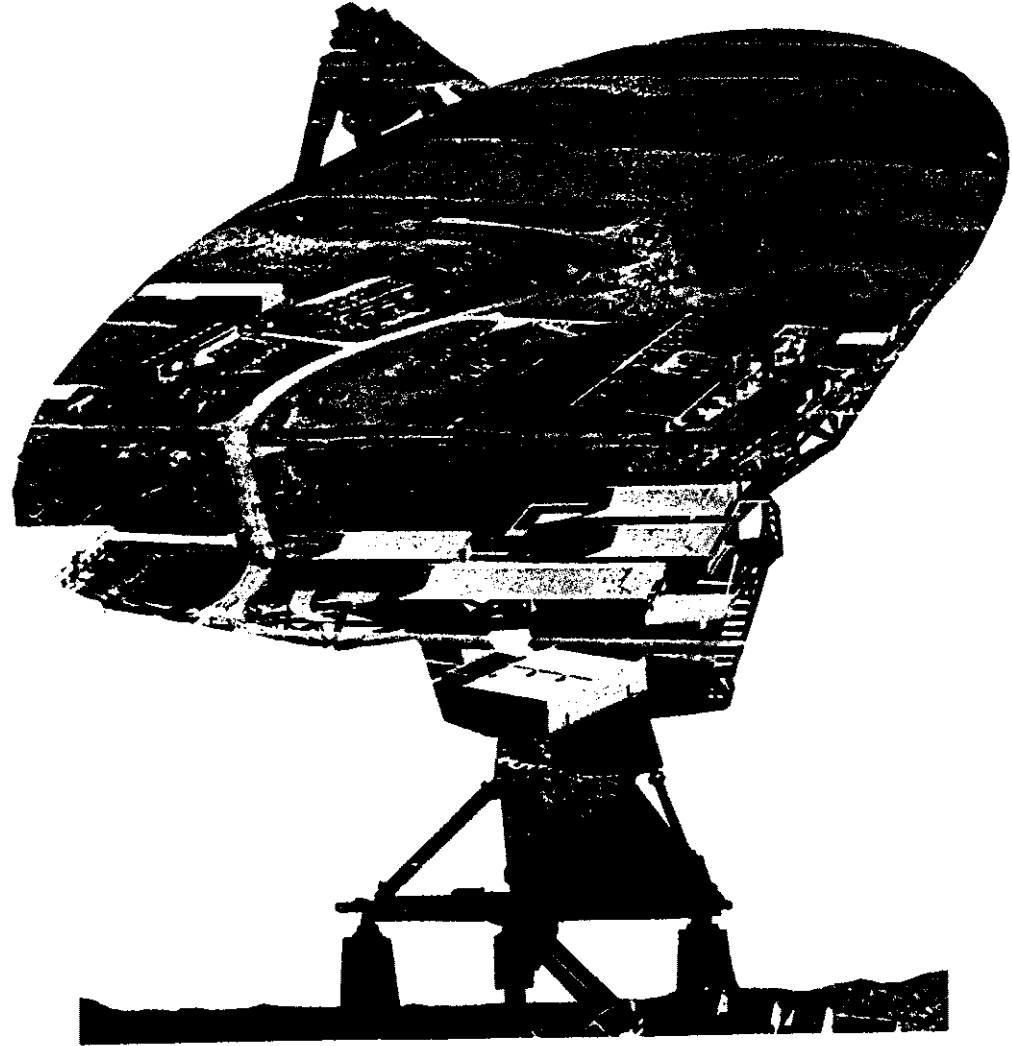
