

Dear Ing. Ramirez Thomas:

Pursuant to the terms of this letter agreement, Gold and Liebengood will provide the full range of services to the Camara Nacional de la Industria Pesquera, to including monitoring, reporting and advocacy on issues of direct or indirect interest to CANAINPES before the U.S. Congress and the Administration.

Gold and Liebengood will assist in the development of necessary materials to be used in the above efforts.

Gold and Liebengood will analyze and provide written reports on the political, legislative and industrial influences impacting and motivating the above-described developments.

Gold and Liebengood will coordinate these efforts fully with the Camara and individuals/entities it might identify, and will have primary responsibility for coordinating the related efforts of other Washington consultants to CANAINPES. Specifically, Gold and Liebengood will subcontract for general consultation services with the firm of O'Connor and Hannon. Should the role of O'Connor and Hannon evolve, by necessity, into one requiring a more time-intensive concentration on active advocacy, Gold and Liebengood will consult with the Camara any fee increases for that firm which might be necessary and appropriate. Therefore, the fee arrangement discussed below would be adjusted accordingly with any future increases for O'Connor and Hannon.

Gold and Liebengood will make all necessary and appropriate filings pursuant to the Federal Regulation of Lobbying Act and the Foreign Agents Registration Act.

In consideration for the services described herein, CANAINPES will compensate Gold and Liebengood at the rate of U.S. \$24,000 per month beginning 1 February 1994. Expenses will be additional and will be passed through to the client on a monthly basis without mark-up. Extraordinary expenses, such as travel, will only be incurred upon prior approval of the client. Payment will be made

by wire transfer upon invoice within 30-days of receipt of the invoice.

For the 2-month period covering 1 February 1994 through 31 March 1994 the fee will be paid under the following schedule: For services rendered during the month of February, the Camara will be billed U.S.\$15,000.00 for payment on invoice, U.S.\$4,500.00 to be paid with the invoice for services rendered in April, and U.S.\$4,500.00 to be paid with the invoice for services rendered in May. Similarly, for services rendered during the month of March, the Camara will be billed U.S.\$15,000.00 for payment on invoice, U.S.\$4,500.00 to be paid with the invoice for services rendered in June, and U.S.\$4,500.00 to be paid with the invoice for services rendered in July.


The term of this agreement will be for 6-months, commencing February 1, 1994 through July 30, 1994, at which time the parties will agree upon the terms for a continued relationship. Either party may cancel this agreement upon 30-days written notice.

Invoices will be rendered on a monthly basis, accompanied by a written report describing all activities undertaken on the client's behalf during that invoice period.
