

Dear Lic. Artolozaga:

Pursuant to the terms of this letter agreement, Gold and Liebengood will provide monitoring and reporting services, as well as advice and consultation to the Camara regarding U.S. Congressional and Administration developments impacting the Mexican sugar industry.

Gold and Liebengood will analyze and provide written reports on the political, legislative and industrial influences impacting and motivating the above-described developments. We will coordinate these efforts with the Administration, with the appropriate Congressional decision-makers, and the Mexican Government as directed by the Camara. Finally, Gold and Liebengood will make all necessary and appropriate filings pursuant to the Federal Regulation of Lobbying Act and the Foreign Agents Registration Act.

In consideration of the upcoming leadership elections within the Camara, the term of this initial agreement shall include the period of February 17, 1994 through March 23, 1994, at which time Gold and Liebengood and the Camara will negotiated the terms for a continued relationship.

In further consideration of the above circumstances, for the services described herein, the Camara will compensate Gold and Liebengood in the amount of U.S.\$5,000.00 by wire transfer upon invoice, plus reasonable expenses. Expenses will be passed through to the client on a monthly basis without mark-up. Extraordinary expenses, such as travel, will only be incurred upon prior approval of the client.


