

Registrant has been engaged by KAE to assist it in selling multibeam sonar mapping systems to the U.S. government. Specifically, registrant will present KAE's position (concerning its GATT-sanctioned right to compete for U.S. government procurements) to the legislative and executive branch. In carrying out this responsibility, registrant anticipates preparing legal memoranda and supporting documents concerning U.S. trade law and policy for presentation to, and arranging conferences with, Congressmen, Congressional staff and officials from the executive branch, including the USFR and DOD. Registrant also anticipates commenting on authorization and appropriations bills and law with respect to the extent such bills and law would affect KAE's ability to compete for U.S. government procurements of multibeam sonar mapping systems.


