

Privacy Act Statement. One copy is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of such documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. Finally, the Attorney General transmits an annual report to the Congress on the Administration of the Act which lists the names of all agents and the nature, sources and content of the political propaganda disseminated or distributed by them. This report is available to the public.

Public reporting burden for this collection of information is estimated to average 1.5 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. 



AGREEMENT

This agreement extends the contract dated February 4, 1988 between Sawyer Miller Group ("SMG") and the Fundacion de Colombia en el Exterior ("Foundation").

1. Terms of Agreement

This agreement commences January 1, 1991 and shall continue until December 31, 1991.

2. Services

SMG shall provide consultation to the Foundation for the purpose of improving Colombia's image abroad. SMG shall manage a program consisting of advertising, strategy and message development, public relations, research, analysis, trip logistics, and other related and necessary services.

3. Payment

The Foundation shall pay SMG funds sufficient to implement the communications program as budgeted in detail in Attachment I (see below). The schedule of payment for 1991 is as follows:

Between January 1 & March 31	\$US 450,000.
Between April 1 & June 30	\$US900,000.
Between July 1 & September 30	\$US975,000.
Between October 1 & December 31	\$US776,500.
Total for 1991	\$US 3,101,500.

4. SMG Fees

SMG shall charge consulting and management fees as outlined in Attachment I. SMG shall submit on a monthly basis progress reports including statements of staff time billed. Where the time exceed SMG's minimum retainer, the Foundation will be billed at the following rates:

Partners	\$ US 350 per hour
Sr. Associates	\$ US 250 per hour
Associates	\$ US 200 per hour
Jr. Associates	\$ US 150 per hour
Assistants	\$ US 75 per hour

5. Expenses

All reasonable and necessary out-of-pocket expenses (travel, meals, telephones, messengers, faxes, etc.) will be billed monthly at cost plus a 15% administrative fee. Any additional project costs (research, artwork, design, production, etc.) must be approved by the Foundation prior to our incurring any reimbursable expenses.
