WSUK has hired the registrant to create a website (www.nigerianext.com) to promote Nigeria's Transformation Agenda. The work assigned to the registrant and the budget are described in more detail in response to Question 8 below.

The Registrant has created a website (www.nigerianext.com) for the Government of Nigeria to promote Nigeria's Transformation Agenda, which is a comprehensive plan to modernize the economy and improve public services and governance. The website was launched on January 6, 2015. The registrant is responsible for designing and building the website, maintaining the website, developing content for the website and promoting the website. The promotion of the website is expected to include paid digital promotion. The registrant may also be engaged to provide follow-up public affairs. The total budget for the website is \$617,000, which includes all fees and expenses, including the paid digital promotion.
