The registrant will provide public relations services to the foreign principal to promote Cape Town and South Africa as a tourist destination. Registrant's specific services will include: responding to media requests for information, contacting US media, and counseling client on messages to best position Cape Town and South Africa as a tourist destination to media in the US. The budget for fees and expenses is not to exceed \$100,000.
