Current grants and funding from Canadian government agencies are:

- ° For the period April 1, 1986 - April 31, 1987, \$75,000.00 from Environment Canada.
- ° For the period April 1, 1986 - April 31, 1987, \$50,000.00 from the Ontario Ministry of the Environment.

NOTE: These funds are spent solely in Canada in furtherance of the Coalition's Canadian interests.



They will prepare and distribute written materials regarding acid rain to individuals and organizations in the United States and Canada, and will be interviewed by American media.


Foreign Principal: Canadian Coalition on Acid Rain

Dear Jeffrey:

Further to the meeting of the Board of Directors on May 24, 1986, we are writing to propose the following terms for an agreement between the Coalition and ourselves (or a legally constituted body controlled by ourselves) for the period 1 October 1986 - 30 September 1987.

RENUMERATION AND TERM

The Canadian Coalition on Acid Rain undertakes to pay us the sum of \$100,000 in 12 equal monthly installments on the first day of every month commencing 1 October 1986, for the period 1 October 1986 - 30 September 1987 for our services as set out in Schedule I attached.

SERVICES

We agree to undertake projects and activities on behalf of the Canadian Coalition on Acid Rain as set out in Schedule I attached during the period 1 October 1986 - September 1987.

CONSULTATION

Pursuant to the Resolution of the Board of Directors passed on May 24, 1986, we agree that we will inform you of new clients taken on by us apart from the Coalition.

EXPENSES

The Canadian Coalition on Acid Rain undertakes to pay all expenses and disbursements incurred by us in relation to carrying out our responsibilities under this agreement. In this regard, we undertake to prepare a Coalition budget for the contract period, for approval by the Board of Directors. Any significant departure from this budget will require the prior approval of the Board of Directors.

REVIEW OF PROGRESS AND RENEWAL OF CONTRACT

We agree to review progress made during the contract period with the Board of Directors at a meeting to be held on or about the first day of June 1987, and to jointly determine at that time the terms and conditions of a subsequent contract between ourselves and the Coalition beyond 30 September 1987. We also agree to report to the Management Committee of the Coalition (to be appointed by the President) to ensure that the terms of this agreement are being fulfilled. We will prepare written reports on a bi-monthly basis for the Board of Directors, using as a reference the activities set out in the attached Schedule of Work.


We also agree that the contract must be renegotiated if, by virtue of acceptance of employment elsewhere, either one of us are not available to fulfill the terms of this agreement.


TERMINATION

This agreement can be terminated by either party upon 60 days written notice to the other party.



SCHEDULE I

Set out below are the services we undertake to render to the Canadian Coalition on Acid Rain in return for the remuneration set out in the attached Letter of Agreement:

- We will oversee the ongoing implementation of the Coalition's direct mail campaign in collaboration with Stephen Thomas and Associates, and with David Love of the Board of Directors, and, on behalf of the Coalition, we will renegotiate grants (if available) for the 1986-1987 period with the Federal Department of the Environment and the Ontario Ministry of the Environment.
- We will manage the affairs of the Coalition including such matters as the regular payment of bills from Coalition funds, submission of invoices to Environment Canada, calling of bi-annual meetings of the Board of Governors and arrangement of periodic meetings of the Board of Directors as necessary.
- We will publish the Coalition's bi-monthly newsletter pursuant to the terms of the current agreement between the Federal Department of Environment and the Coalition.
- We will pursue efforts to encourage implementation of regulatory programs reducing sulphur and nitrogen oxide emissions in the provinces of New Brunswick and Nova Scotia, and to that end, will contact Maritime interest groups, press and media, and travel through the Maritimes as necessary.
- We will assist the American Friends of Muskoka regarding their 1986 summer meeting (assistance re speaker and logistics).
- We will work with members of the Board of Directors to implement a radio commercial campaign this summer aimed at American tourists in Ontario. The purpose of the campaign is to alert American tourists of HR 4567, the bill which recently passed the Health and Environment sub-committee of the House of Representatives, and to call for their support of this bill.
- We will endeavour to ensure that the Select Committee on the Environment of the Ontario Legislature holds oversight hearings on the Ontario acid rain program. We will work with and appear before this committee as necessary.
- We will continue to monitor implementation of the acid rain information program to be launched through the use of the non-resident fishing license program in the Province of Ontario.
- We will continue to work with Pennsylvania interest groups and organizations to implement an acid rain education effort in that state, and to encourage the formulation and passage of acid rain control legislation by the Pennsylvania state legislature.

- We will work to ensure that any discussions on acid rain held during the upcoming summit meeting in March, 1987, between President Reagan and Prime Minister Mulroney will be widely covered by Canadian and American press and media. We will also make every effort to ensure that press and media coverage of such discussions, and the actual discussions themselves, focus on the topic of emission reductions. At the same time, we will assist officials of the U.S. National Wildlife Federation with the organizing of their annual meeting, also in March, in Quebec City in order to ensure that acid rain remains a major issue of this organization, which is the largest conservation membership group in the United States.

- We will ensure that the appropriate quarterly and bi-annual filings under the U.S. Federal Regulation of Lobbying Act and the U.S. Foreign Agents Registration Act are made on the Coalition's behalf.

- We will continue to monitor the progress of acid rain control legislation in the House of Representatives and the Senate in order to alert Canadian media and policy-makers about developments and action required. Included here will be periodic trips to Washington to encourage support of legislation by Members of Congress and members of the Senate.

- We will continue to supervise and participate in the general work of the Coalition. This includes periodic press and media interviews on all aspects of the acid rain question, provision of general packages of information to the public, occasional speaking engagements, and periodic advice to federal and provincial government officials, and their U.S. counterparts, as required.

- In addition to the above-mentioned activities, there will no doubt arise opportunities for work not enumerated above which cannot be foreseen at the present time. As in the past, we will take advantage of such opportunities as they arise and to the extent possible.


Dear Jeffrey:




