



This letter confirms the representation of Dassault Industries, and its related U.S. companies, Falcon Jet Corporation, Midway, and APRO by C & M International Ltd. with respect to the administrative review regarding antifriction bearings from France. As has been discussed, C & M International Ltd. has retained the services of Crowell & Moring to provide legal analysis, advice and representation, as necessary or appropriate, in this administrative review.

1. Billing Procedures.
