

¹Political activity as defined in Section 1(o) of the Act means the dissemination of political propaganda and any other activity which the person engaging therein believes will, or which he intends to, prevail upon, indoctrinate, convert, induce, persuade, or in any other way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of the Government of a foreign country or a foreign political party.

CONTRACT

15 June, 1987

The Embassy of Japan, 2520 Massachusetts Avenue, N.W., Washington, D.C. (hereinafter referred to as the "Embassy") and Washington Resources and Strategy, Inc., 536 Seventh Street S.E., Washington D.C. (hereinafter referred to as "Washington Resources") hereby agree and contract as follows:

1. Washington Resources shall provide the Embassy with a series of reports entitled "The Presidential Election, 1988: Update and Analysis".
2. The report will be submitted on a monthly basis to the Embassy until March, 1988.

The Embassy shall pay Washington Resources US\$ 5,000.00 (Five Thousand Dollars). This payment shall be made in two parts; US\$ 2,500.00 on November 1, 1987 and US\$ 2,500.00 on March 31, 1988.

4. The report and its contents will be the property of the Japanese Government for its internal purposes.
