

IPAC to work for CCNAA on a monthly retainer of \$25,000 plus agreed out-of-pocket expenses for a period of 6 months, beginning March 1, 1992. Agreement can be terminated on 30 days notice or extended by mutual agreement. Tasks to be performed by IPAC are to assess USG views of Republic of China (ROC) defense needs and capabilities, assist CCNAA to convey ROC self-defense needs to USG and to develop and implement strategies for securing USG approval for self defense equipment transfers to the ROC and integration into the ROC armed forces.

Develop briefings, meet with USG officials to present such briefings, meet with potential supplier contractors to develop program plans.
