



PROPOSAL TO THE PRIVATE SHIRT INDUSTRY

The following is a proposal from International Development Systems, Inc. and Manchester Associates, LTD. (hereinafter "IDS/MA") setting forth the elements and conditions for an arrangement between the private shirt industry (hereinafter PSI) and IDS/MA regarding the Costa Rica/ United States consultations on trade in cotton and man-made fiber non-knit shirts (category 340/640).

These consultation were requested by the United States on February 2, 1987 under the provisions of the Costa Rica/ U.S. agreement on a consultative Mechanism effective by exchange of notes on September 22, 1980 and February 7, 1984.

Under this arrangement, IDS/MA will provide to the PSI political, as well as economic briefs for these consultations.

The economic brief, although focused on trade in category 340/640, will review and analyze current U.S. textile trade policies and the application of the caribbean basin initiative within these policies. Both these briefs will explain and recommend how these stated policies may best be used during these consultations to avoid, or lessen, any adverse impact of threatened U.S. restraining actions on Costa Rica's textile and apparel trade.

The economic brief will include a full analysis of the market disruption claim which, in the view of the United States, justifies restraints on Costa Rica's trade in category 340/640.

The brief will show where the U.S. claim is weak and inconsistent with the fundamental requirements of the Costa Rica/U.S. agreement and where it is in contradiction to stated U.S. policies for the region and the basic international principles as contained in the Arrangement Regarding International trade in textiles (MFA).

The political brief will include a strategy of how to take advantage of the concern of all elements in the U.S. political system for the

economic health of the region, particularly Costa Rica, and how this concern can be used to bring pressure on U.S. textile negotiators for improved access for textiles. The brief will fully identify and explain the issues most central to these consultations.

IDS/MA will also provide the background and comparative statistics for these consultations. These will include a listing of all U.S. shirt quotas and trade so that any U.S. proposal can be analyzed within the overall context of the U.S. program. Data on Costa Rica's trade will be prepared and evaluated to put into accurate and proper perspective Costa Rica's role in the overall textile and apparel trade of the United States.

Senior staff of IDS/MA will assist in developing a negotiating position as well as the strategies and tactics necessary to carry it out. IDS/MA will also be available for consultations and assistance during the consultation process.

Professional fees for services will be billed on an hourly basis, not to exceed a total sum of \$30,000. The hourly fees for IDS/MA are as follows:

Principals	\$150 - \$ 175
Senior Associates	up to \$ 100
Economists	up to \$ 75

The cap of \$ 30,000 would cover preparation of the brief and all other analytical and statistical materials, presentation to and meeting with representatives of the Private shirt Industry and their advisers, lobbying and representations to U.S. officials, and assistance before, during, and immediately after the negotiations.

IDS/MA will also be reimbursed for all out-of-pocket expenses including local transportation, telephone, telex travel and living expenses outside of the Washington, D.C. area, copying of documents, secretarial overtime, business meals, and other expenditures excluding normal overhead expenditures. No major expenses such as travel outside the United States will be incurred unless specifically agreed to by the Private shirt Industry.
