It was established by a special law in Japan as a non-profit, Japanese government-supported organization dedicated to promoting mutually beneficial economic, trade and investment relations between Japan and other nations. In the USA, JETRO currently maintains offices in New York, San Francisco, Los Angeles, Houston, Chicago and Atlanta. These offices provide information relating to the Japanese economy and business, as well as US-Japan relations. The functions of JETRO's US offices are believed to be very similar to those of the United States Trade Center (of the US Department of Commerce) in Japan. As the Atlanta-based office of JETRO, JETRO Atlanta provides to public officials, associations, individuals and any other interested parties, information and materials relating to various aspects of the Japanese economy and business, as well as US-Japan economic and trade relations. JETRO Atlanta also monitors the development of US economic and market conditions for JETRO.
