


CONTRACT


The Embassy of Japan, 2520 Massachusetts Avenue, NW, Washington, D.C. 20008 (hereinafter referred to as the "Embassy") and Paul H. DeLaney, Jr., 1826 Jefferson Place, NW, Suite 201, Washington, D.C. 20036 (hereinafter referred to as "DeLaney"), have agreed as follows:

1. DeLaney shall provide the Embassy with counseling on agricultural issues as well as such matters as the Embassy will request.
2. The Embassy shall pay the amount of U.S. \$20,000 (Twenty Thousand Dollars) on an annual retainer for the period April 1, 1990 through March 31, 1991.
3. This contract shall come in force as of the first day of April, 1990 and shall be in effect until March 31, 1991. On the condition that the Diet approves the budget of fiscal year 1990 in addition to the already approved provisional budget.

Contract

The Embassy of Japan, 2520 Massachusetts Avenue, NW, Washington, D.C. 20008 (hereinafter referred to as the "Embassy", and Paul H. DeLaney, Jr., 1826 Jefferson Place, NW, Suite 201, Washington, D.C. 20036 (hereinafter referred to as "DeLaney"), have agreed as follows:


1. DeLaney agrees to undertake additional initiatives and to draw on extensive studies, reports, advice and counsel provided to the Embassy over the last two years for purposes of strengthening the present positive relationship which exists between the United States agriculture and Japan.
2. Based on the considerations noted above, DeLaney agrees to undertake with senior officials of private sector American agriculture and others such discussions, meetings and communications as may be necessary to bring about a better understanding and appreciation of the importance of the recent very positive trends regarding United States agricultural exports to Japan so as to enhance the prospects for a better overall economic, political and social relationship between the United States and Japan. In this regard, such efforts will be directed to bringing about an increasing United States public awareness of the substantial benefits that have accrued to United States agriculture as a consequence of these developments.
3. DeLaney agrees to provide the Embassy with a report on this project by March 31, 1990. This report shall be treated as private and confidential.
4. The Embassy agrees to pay DeLaney \$15,000 (Fifteen Thousand United States Dollars) upon the receipt of the report.
