

Dear Mr. Lee:

This letter constitutes an agreement between Michael Lee and his companies and David O'Brien & Associates. Our firm agrees to represent Michael Lee and his companies on the overseas studies programs to enhance the image of the programs in the United States with the goal of insuring that student applicants are accorded unbiased, fair and equal treatment by the American Institute in Taiwan in evaluating student visa applications. In addition, Mr. O'Brien agrees to serve as the negotiator for the detailed agreement between Jovian Publishing and Friends University.

Fees for services will be a \$5,000 per month retainer due on the first day of each month starting April 1, 1990. Out-of pocket expenses (meals, cabs, long distance telephone and approved travel expenses) will be billed separately. In the event that our services have not been successful, this agreement may be cancelled upon 30 days notice.
