

MACBRIDE - MAINE

1. I enclose a signed copy of the proposal you submitted for you to represent the British Government to the Maine legislature on the subject of corporations doing business in Northern Ireland.
2. The Department of Economic Development, responsible for paying the bills, have agreed to the contract at the rates negotiated, namely a retainer of \$2500 (please submit bill to me) and \$110 per hour plus expenses thereafter should a Bill be filed. I must ask you to limit this sum to a maximum of \$7,500 when the contract would have to be reviewed. I also reserve the right to terminate the contract at any stage. I hope you find this acceptable.
3. On another matter, the Speaker of the House, John Martin with other leading legislators from around the country recently visited England as participants in a "public/private leadership conference" held at Brockett Hall. I would like to call on the Speaker possibly with a representative from the Embassy in Washington to hear his comments on the conference and to begin addressing the MacBride issue. I rely on you to judge the correct timing for such a call and to let me know the most propitious dates.

Monitoring and Lobbying Legislation

Dear Ann:

This letter is in response to your request when we spoke on the telephone today that I write to you with a proposal with respect to this firm's representation of your Government before the 1990 session of the Maine Legislature. As you know from prior correspondence from me earlier this fall, we expect to have legislation filed requiring disinvestment in corporations doing business in Northern Ireland that do not subscribe to the MacBride Principles, which legislation should be either identical or very similar to the legislation which Governor McKernan vetoed two years ago when we were representing your Government concerning that matter.

We would propose that we receive an initial retainer as soon as possible in the amount of Two Thousand Five Hundred Dollars (\$2,500.00) which will cover our time in monitoring the situation here in Maine until such time as a bill is actually printed and formerly introduced before the 1990 legislative session. Once a bill has been printed, we would expect that you would request us to immediately register under the Maine Lobbyist Registration Act to lobby on behalf of your Government in opposition to that legislation and, for this lobbying work, we would propose to bill our time that is expended in carrying out that work at the rate of \$110.00 per hour. Furthermore, as you know from our representation of your Government in the past, other attorneys and paralegals in our firm may work on matters from time to time and their billing rates may vary from the quoted rate of \$110 per hour; however, those rates will always be less than the quoted rate in this letter. We

would also be reregistering with the United States Department of Justice as agents for a foreign government.


Our firm also charges our clients for out-of-pocket expenses such as long-distance phone charges, fax charges, photocopies, overnight courier service charges, and similar costs.

As was the case when we represented your Government in the past, you will receive, at 30-day intervals, a statement showing the status of your account with us, which statement will be fully itemized with respect to the time that has been expended in representing you, as well as the costs for which we are asking reimbursement. Furthermore, it is our policy to expect that outstanding balances for our services and expenses will be paid within 30 days of mailing to our clients and we also reserve the right to suspend our services whenever a past-due outstanding balance equals or exceeds \$2,500.00.

In the event that you obtain approval of the retainer and fee agreement which I have proposed in this letter for you, I would ask that you please sign the enclosed duplicate original and return it to this office as soon as possible with a check in the amount of the above-stated retainer. The other original of this letter which I have also signed is for you to retain for your records concerning this matter.

Should you have any questions or concerns with respect to the proposal that I have made in this letter for our representation of your Government, I would be pleased to discuss them with you. Thank you.
