



Article 1 Monitoring American Sugar Policy

In 1990, American Sugar Policy will be dominated by two elements: the endeavors of the administration to modify the import quota system to bring in into conformity with the GATT and also the elaboration of a new Farm Bill.

These two elements both risk having an important impact on the sugar market, in so far as the structure of the importation system may be modified and the administration will attempt to achieve a lowering of the loan rate.

The combination of these two measures is susceptible to modifications of the future equilibrium of the world market and, subsequently, the competition between natural sugar, corn isoglucose and synthetic sweeteners on the U.S. domestic market.

Euroconsultants, Inc. will keep Sucre Union and Generale Sucrيره informed of developments in agricultural policy which may arise in the United States in the sugar sector and will communicate to them all studies and reference documents published by the U.S.D.A. and Congress which Euroconsultants, Inc. has access to.

Article 2 Monitoring of Competitors

Euroconsultants, Inc. will keep Sucre Union and Generale Sucrيره informed of the activities of the principal companies involved in the production of natural or synthetic sugar. To do this, Euroconsultants, Inc. will use information available from the technical press, as well as economic studies performed by the U.S.D.A. on the American sweetener market.

Article 3 Monitoring of the GATT Negotiations

Euroconsultants, Inc. will inform the companies Sucre Union and Generale Sucrيره on the state of progress of the agricultural negotiations, and monitor dispute settlement mechanisms with respect to U.S. or E.C. sugar policies.

Article 4 Missions / Meetings

Euroconsultants, Inc. will organize meetings in Washington on Sucre Union's and Generale Sucrيره's behalf concerning all the sugar policy matters which are the object of this contract.

The costs and expenses incurred through such missions will be billed separately.

Article 5 Confidentiality / Exclusivity

All information relative to the activities of American companies, will be treated in a confidential and reserved manner for the exclusive use of Sucre Union and Generale Sucrيره.

Article 6 Honorariums

The consulting fee for Euroconsultants, Inc. is fixed contractually at \$25 000 USD/year. This fee includes subscription costs to technical publications, the purchase of studies and documents published by the U.S. government as well as the costs of expedition of documents and telecommunications.

These fees are payable each trimester by direct payment in USD to the bank account of Euroconsultants, Inc. at the beginning of each trimestral period.

Article 7 Duration

The present contract is established for the renewable duration of one year. The contract may be discontinued at the maturity date by one or other of the parties, on the condition of three (3) months notice. The clauses of this contract may be used as a codicil at the end of the first year if the two parties so agree.

Article 8 Date of Effectiveness

This contract takes effect March 1st, 1990 for the duration of one year.

CONTRAT

LE PRESENT CONTRAT EST CONCLU ENTRE

- Les sociétés SUCRE-UNION et GENERALE SUCRIERE

d'une part.

ET:

- La société EUROCONSULTANTS, INC., société de droit américain incorporée dans le DELAWARE, ayant son siège social à 1455 Pennsylvania Avenue, Suite 1180, WASHINGTON, D.C. 20004, ETATS-UNIS, représentée par M. Ralph ICHTER, President, d'autre part.

Article 1: Suivi de la politique sucrière des Etats-Unis

Pour 1990, la politique américaine en matière sucrière sera dominée par deux éléments: les tentatives de l'administration de modifier le régime des quotas à l'importation pour se mettre en conformité avec les conclusions du panel du GATT d'une part, l'élaboration d'un nouveau Farm Bill d'autre part.

Ces deux éléments risquent tous deux d'avoir un impact important sur les marchés du sucre, dans la mesure où le régime d'importation risque d'être modifié (on parle d'un contingent tarifaire unique) et où l'administration tentera d'obtenir une baisse du loan rate (prix d'intervention).

La combinaison de ces deux mesures est susceptible, à terme, de modifier l'équilibre du marché mondial ainsi que la compétitivité relative des sucres naturels, des isoglucoses de maïs et des édulcorants de synthèse sur le marché domestique américain.

EUROCONSULTANTS, INC. tiendra SUCRE-UNION et GENERALE SUCRIERE informées des développements de politique agricole intervenant aux Etats-Unis dans le secteur du sucre et s'engage à leur communiquer toutes études et documents de référence publiés par l'U.S.D.A. et le Congrès dont EUROCONSULTANTS, INC. pourra avoir communication.

Article 2: Observation de la concurrence

EUROCONSULTANTS tiendra SUCRE-UNION et GENERALE SUCRIERE informées des activités des principales sociétés américaines engagées dans la production de sucre naturel ou de synthèse. EUROCONSULTANTS, INC. utilisera à cet effet les informations disponibles dans la presse spécialisée, ainsi que les études économiques réalisées par l'U.S.D.A. sur le marché américain des produits sucrants.

Les études de marché nécessitant des recherches approfondies, autres que bibliographiques pourront faire le cas échéant, l'objet de conventions séparées.

Article 3: Suivi des négociations du GATT

EUROCONSULTANTS, INC. s'engage à informer les sociétés SUCRE-UNION et GENERALE SUCRIERE de l'état d'avancement de la négociation agricole du GATT, ainsi que de l'état des procédures de règlement des différends mettant en jeu les politiques sucrières des Etats-Unis ou de la Communauté.

EUROCONSULTANTS, INC. s'engage, au titre de l'article 3, à communiquer à SUCRE-UNION/GENERALE SUCRIERE les informations recueillies à Washington, relatives aux prises de position de la Commission dans la négociation agricole du GATT.

Article 4: Missions / Entretiens

EUROCONSULTANTS, INC. pourra organiser pour le compte des sociétés SUCRE-UNION/GENERALE SUCRIERE des entretiens à Washington sur l'ensemble des questions de politiques sucrières faisant l'objet du présent contrat.

Les frais et débours engagés à l'occasion de telles missions seront facturés sur justificatifs.

Article 5: Confidentialité / Exclusivité

Les informations relatives aux activités des sociétés américains seront traitées de manière confidentielle et réservées à l'usage exclusif de SUCRE-UNION/GENERALE SUCRIERE.

Article 6: Honoraires

La rémunération d'EUROCONSULTANTS, INC. est fixé forfaitairement à 25 000 USD par an. Cette rémunération comprend les frais d'abonnements à des revues spécialisées, l'achat des études et documents publiés par le gouvernement américain ainsi que les frais d'expédition de documents et de télécommunications.

Ces honoraires sont payables trimestriellement, par virement en USD au compte de la société EUROCONSULTANTS, INC. au début de chaque période trimestrielle.

Article 7: Durée
