

These sales are lawful and do not violate the national security interests and do not violate the national security interests or export regulations of the United States, and the unfounded assertions by the adverse party should not affect a recent decision of the International Trade Commission that is favorable to AGIE and Elox Corporation.

Needless to say, we are very excited about starting up a program with you. We are looking forward to a successful and mutually rewarding relationship.

For both our records, this confirms our agreement, effective March, 1990, that you have hired G.S. Schwartz & Co. Inc. to conduct a public relations program for Elox and AGIE.

G.S. Schwartz & Co.'s fee for its professional services will be \$5,000 per month for the first three months and \$4,000 thereafter to cover staffing, management and reporting on your program.

Basic expenses are estimated at several hundred dollars per month, although travel, production items or special events approved by you will increase this. Basic expenses include telephone, postage, copying, messengers, shipping, transportation, publications, freelancers, press charges and related items. Per standard industry practice, we will bill \$1,500 at the outset to be used as a revolving credit for future disbursements.

Certain special events, projects or activities may require additional budgets. These and others will be submitted to you for approval in advance if and when required.

While planned and staffed as an annual program, this agreement may be cancelled by either party on 60 days advance paid notice in writing anytime after the first six months, as paid severance to cover our winding down press contacts and other details.
