

4. Describe fully the nature and method of performance of the above indicated agreement or understanding.

The Registrant will assist Thomson-CSF, Inc., a Thomson-CSF U.S. entity with offices at 2231 Crystal Drive, Arlington, Virginia 22202, in understanding and developing a strategy to support a favorable decision on the continuation of U.S. funding support for the Multiple Launched Rocket System-Terminal Guided Warhead (MLRS-TGW) as a NATO cooperative development and technology demonstration program. The services of Arnold & Porter, a Registered Agent, will be used. The Registrant will render advice and counsel on U.S. laws, regulations and policies that may affect or relate to the activities of the foreign principal, including but not limited to, Department of Defense funding issues. The fee for such representation is to be determined periodically based on usual daily and hourly charges, plus out-of-pocket expenses. The duration of the agreement is indefinite.


