



In connection with our arranging for the placement of **The Embassy of Switzerland** video programs with junior and senior high school teachers, school library services, and other interested audiences throughout the United States, Video Placement Worldwide (VPW), a division of JD Kommunikaters, Inc., proposes the following terms for our agreement:

VPW will duplicate **The Embassy of Switzerland** video titles individually on separate high quality video tapes directly from your duplication masters. The Embassy will select which titles will appear on the tapes.

The Embassy of Switzerland videos will be placed with educators, group leaders and organizations who have requested the Embassy programs.

VPW will select the school locations and organizations in the regions most preferred by the Embassy of Switzerland on where to place the videos. VPW will follow any Embassy placement preferences or instructions.

If available, Embassy literature will be sent with the videos at no additional charge, unless it increases the postage.

VPW will invoice the Embassy of Switzerland as the group placements are completed.

VPW will provide the Embassy of Switzerland with an advance audience report based on the information given to VPW by the group leaders actually receiving the videos.

A year end user survey will be conducted approximately one year after distribution begins. The results of that detailed survey, which can be customized for the Embassy, will be provided to the Embassy of Switzerland.

The names and addresses of the video users will remain on file and available to the Embassy of Switzerland at any time after the initial video placement.

VPW will make available to the Embassy of Switzerland the use of our educational newsletter for notifying group leaders about important information updates concerning important dates or recent events in Switzerland.

Each school and group placement will be billed at a rate of \$8.00 per placement plus postage (currently \$0.66 per placement).

The total budget for school and group placement will not exceed \$30,000 for the period beginning January 1, 1995 through December 31, 1995, without prior written approval from the Embassy of Switzerland.

The Embassy of Switzerland will pay all invoices in U.S. dollars within 30 days of receipt. A late charge of 1.5% per month will be added to all past-due balances.

Upon cancellation of this agreement, VPW will cease to honor new requests immediately, or upon a designated date.

The Embassy of Switzerland shall, at its own cost, indemnify, defend, and hold VPW harmless from any claim or demand which may be made or asserted by reason of a claim of violation or infringement of trademark, trade name, copyright, literary, artistic, dramatic, personal, private, civic, or property right, or the right of privacy of any individual, firm, corporation, or association, arising from material provided by the Embassy of Switzerland to VPW. VPW shall have the right to participate in the defense of any action or actions brought in connection therewith.

The terms of this agreement shall be in force upon signature of the agreement.

If the foregoing terms meet with your approval, kindly sign both copies of this agreement below the word "Accepted" and return one copy to us. It shall then constitute the entire agreement between us.
