



Thank you for the opportunity to work with the Bank of Tokyo on the problem we discussed last Thursday.

This letter outlines how we charge for our services. Please review and sign it, then return it to me.

FEES

Agency (Rockey Company) charges will be based on hourly rates of persons assigned to your account. My rate is \$150 an hour, support staff is \$40 an hour. The bill will be reviewed at the end of the monthly billing cycle and we will jointly determine whether to continue on an hourly basis, monthly retainer, or another mutually agreeable basis.

EXPENSES

Any materials and services purchased on behalf of the Client (Bank of Tokyo) from outside suppliers will be billed to and paid for by the Client. To cover the costs of handling, maintaining accountability, and financing transactions, a handling cost of 17.65% will be charged for all expenses except the following, which will be billed net: telephone; telecopier; travel; and insurance for any photos, transparencies, prints and artwork.

Costs associated with printing, photography, audio/visual and other major services ordered by the Agency on behalf of Client and provided by third parties will be billed net by the supplier directly to Client whenever possible.
