

An additional area of concern is the humanitarian plight of the Kurdish people of Iraq and Commonwealth Consulting Corporation will seek to develop a greater understanding of the desperate condition of the Kurdish people in northern Iraq and the need for greater humanitarian assistance XXXXXX from the United States and other western nations.

\*Political activity as defined in Section 1(o) of the Act means the dissemination of political propaganda and any other activity which the person engaging therein believes will, or which he intends by prevail upon, indoctrinate, convert, induce, persuade, or in any other way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

AGREEMENT

By this Agreement entered into on the 15th day of March, 1992, between Commonwealth Consulting Corporation (hereinafter Consultant) and the Patriotic Union of Kurdistan (PUK), the Parties agree as follows:

1. Scope of Employment. Consultant will assist in government relations, public relations and media efforts to further the interests of the PUK.

In performing this Agreement, Consultant shall comply with all applicable laws, rules, regulations and policies of the United States of America or any jurisdiction where Consultant's services are to be performed and shall save the PUK harmless from Consultant's failure to do so.

2. Term. This Agreement is intended to be for a period of six months commencing on March 15, 1992. At the end of this period, the PUK will have the option to extend the agreement for an additional period subject to a renegotiation of terms. During the course of this agreement should either party seek to terminate this agreement, it shall so state in writing. Termination shall be effective 30 days after receipt of said written notice of termination

3. Fees. In return for the performance of services described herein, the PUK agrees to compensate Consultant in the amount of \$ 10,000 per month with \$20,000 due upon signature and the remainder paid monthly on the fifteenth of each month.

In addition to such fees, the the PUK shall reimburse Consultant for expenses, such as travel, courier, or long distance telephone, incurred in connection with the provision of services under this Agreement. All travel must be approved in advance by the the PUK.

The the PUK understands and agrees that if this Agreement is terminated for any reason, payment of all expenses and fees incurred to the termination date shall be made within 30 days.

4. Miscellaneous Provisions.

- A. Governing Law. This Agreement shall be governed by the laws of the Commonwealth of Virginia both as to interpretation and performance.
